Sustainability Reporting Training: The Essentials

A. Introduction

The current business world is under increased pressure to provide solutions to the challenges of climate change, good returns on investment, brand reputation protection, and shifting consumer and investors' priorities. Thus, making sustainability (non-financial performance) a core focus of corporate behaviour and approach to meeting the interests of investors not just to provide good financial performance but also positive (tangible & intangible) returns year-on-year. This means companies must align with environmental, social and governance (ESG) demands of their investors. ESG assets are now forecast to hit \$53 trillion by 2025, a third of global assets under management.

Investors, regulators, consumers, and employees are taking more keen interest in non-financial information as there is growing evidence showing a positive link between ESG and value creation. This information can only be provided when companies display a level of transparency as seen with financial information.

This increasing interest in ESG/sustainability data is pressurising Boards and management teams of companies to take a more strategic approach to integrating ESG/sustainability into corporate strategy for a seamless reporting process that focuses on creating value for all stakeholders rather than the traditional focus on shareholders alone.

However, whilst there is no doubting the importance of ESG and its momentum, it is a relatively new business requirement with emerging standards and frameworks making corporate reporting a complex and confusing topic.


